

# **Cookies Policy**

This Cookies Policy sets out how Energy Developments Pty Ltd and all subsidiaries within the EDL group of companies use cookies to recognise you when you visit our website at <a href="http://edlenergy.com/">http://edlenergy.com/</a> (the "Site").

This Cookies Policy explains how we use cookies and other similar technologies to collect information about the way you use the Site.

#### 1. What are cookies?

1.1. As is common practice with almost all websites this site uses cookies, which are tiny, often encrypted, text files that are used by websites to perform certain functions.

#### 2. How do we use cookies?

- 2.1. Information supplied to us using cookies helps us to analyse the profile of our visitors and provide you with an improved online experience.
- 2.2. When you submit data through a form, such as those found on contact pages, cookies may be set to remember your user details for future correspondence.
- 2.3. We use cookies to track how you use our Site by providing usage statistics on things such as how long you spend on the Site and the pages that you visit. Cookies are also used to serve advertisements to your based upon your browsing history and previous visits to the Site.
- 2.4. Whilst this information on its own does not usually constitute your personal information we may combine the information we collect by cookies with your personal information that we have collected from you in order to learn more about how you use the Site, improve our services and continue to produce engaging content.

### 3. Disabling Cookies

- 3.1. You can control, block or restrict cookies by adjusting the settings on your browser (see your browser's "Help" section for how to do this). All cookies are browser specific. Therefore, if you use multiple browsers or devices to access websites, you will need to manage your cookie preferences across all of these elements.
