Reporting to the RNG General Manager, the RNG Operations Support Supervisor is responsible for supporting the RNG Operations by providing support to EDL's fleet of RNG plants. This will include the review of operational efficiencies, vendor procurement, media and inventory management, plant controls/trend analysis, and providing general support for the RNG Plant Teams within EDL's North American Operations. The RNG Operations Support Supervisor will be responsible for achieving metrics related to plant maintenance outages, media selection and consumption rates, plant performance and overall production goals.

### **Key Responsibilities**

- Participate in the staffing rotation for start-up of new RNG facilities.
- RNG asset maintenance leadership, planning and scheduling both internal and external support personnel for existing and developing RNG projects.
- Work with the various operational teams on advanced instrumentation and process (SCADA) control systems.
- Communicate accurately with employees, supervisors, and managers. Performing high level of analytical and trouble shooting skills in both the gas plant and the gas field.
- Work closely with the RNG Management Team, RNG Plant Operation Supervisors and Maintenance Technicians to ensure continuity of support and successful maintenance related outcomes.
- Lead media selection, consumption tracking, procurement and arrange for outside third-party assistance when required and may oversee third-party contractors working onsite.
- Lead the review of RNG Plants maintenance and production processes to ensure plant production and the asset maintenance plans are consistent with business planning goals.
- Lead planning, coordination, and scheduling of major plant maintenance outages
- Be knowledgeable of mechanical preventive maintenance schedules, electrical GEAMS and maintenance schedules in support of RNG Plant compliance.
- Lead the identification of fleet wide critical inventory and spares parts and support the strategy for procuring and maintaining inventory.
- Analyse operations and maintenance data to make recommendations for improving productivity and efficiency in operations.
- Support Operations by ensuring that RNG plants are running at full potential while minimizing direct costs.
