This position can be based at Covel, Texas or Taylor County / Pecan Row, Georgia. From the base location, the successful applicant will be required to travel to all sites within the region on a regular basis.

Key Responsibilities

- Manage multiple Power Station locations in the South East region Covel (TX), Taylor County (GA) and Pecan Row (GA)
- Lead and motivate a team of Operators involved in all aspects of maintaining the Power Stations
- Support the operation of the Power Stations following correct processes and protocols
- Support maintenance strategies in conjunction with the technical services department Power Stations
- Responsible for interfacing with the landfill partner at the Power Stations
- Responsible for the implementation and support of the Company Health, Safety and Environmental Policies and Procedures at the Power Stations
- Ensure compliance of environmental and regulatory regulations, rules and requirements, along with response roles to incidents at the Power Stations
- Operate gas fuelled power plant, spark ignition engines, and all associated power generation and Gasfield equipment
- Operate advanced instrumentation and process control systems
- Perform regular inspection and maintenance of fixed plant, engines and associated equipment
- Undertake electrical and mechanical fault-finding, repairs and reporting
- Carry out routine housekeeping duties
- Schedule daily activities, delegate work tasks to team members and supervise the completion and quality of the tasks
- Responsible to monitor the site employee(s) performance, tardiness, timesheets and overtime
- A working position, the Operations Supervisor handles any/all work tasks as needed at the sites
- Other duties as assigned from time to time by the Company

- Ability to lead, manage and develop the operations team
- Able to work under pressure with minimal frustrations
- Good organizing skills. Able to prioritize and reprioritize.
