Reporting to the Head of Project Delivery and Technical Services North America, this role is responsible for assisting in the technical development of major projects including RNG (renewable natural gas) projects to ensure completion is safely on time and meets the project budget.

### **Key Responsibilities**

- Represent Project Delivery on matters of technical development, permitting, interconnection, design, financial approval, contractor selection and contract negotiations for the various projects
- Develop budgets for project development and obtain organizational approval
- Provide technical guidance in the evaluation of gas interconnect technical specifications and electrical interconnection details for the purpose of selecting process equipment
- Work with the EDL Technical Services group to evaluate LandGEM wellfield gas curves for the purpose of plant sizing
- Assist the EDL Business Development group in forming the basis of agreement during negotiations for gas and electric offtakes
- Lead the pipeline technical development including design and assist with easements
- Provide analysis and key technical inputs for financial models in conjunction with the EDL Finance group to bring projects forward for fiscal approval
- Interface with the EDL Compliance group to apply for all environmental permits for the projects (air, waste, stormwater, etc) and ensure that all wetlands have been evaluated properly
- Prepare specifications, answer RFI's and rank the results for the EPC bidding process
- Evaluate project bids for process and engineering in all phases of plant development
- Support EPC contract negotiations as the lead for Project Delivery in assistance of EDL Legal
- Build relationships with the personnel and contractors at the OEM level
- Report on project progress with tracking reports for adherence to schedule and budget
- Control and co-ordinate communications with the contractor representatives to ensure that the project is initiated within the agreed scope per executed agreements
- Ensure that both the companies' and specific project Environmental, Health and Safety obligations relating to project activities are fulfilled
- Ensure the project complies with statutory and legislative requirements
- Adhere to EDL project management protocol and corporate governance
- Interface with customers and EDL site operations to coordinate project information
- Use EDL risk management tools to evaluate all project risk and specific work-related risks
- Ensure a Safe Workplace for Staff and Customers by the preparation & implementation of project HSE Management Plans and:
- Reporting all risks/hazards/incidents/near misses and accidents, and

- Removing or modifying any unsafe processes or systems.
