The Wellfield Support Specialist works within the North America Fuel team and Global Fuel team within EDL to support activities to maximize fueling for the generation of power electricity and product gas at EDL-North America's Landfill gas business. The Wellfield Support Specialist will support both technically and operationally, with the responsibility of implementing best practices to ensure optimum delivery of landfill gas to EDL-NA's assets, as well as support the GCCS (gas collection & control system) construction events and gas monitoring equipment.

Responsibilities

- Works within the EDL-NA Fuel Team to develop, maintain and maximize sustainable fueling of EDL Landfill Gas (LFG) generation assets
- Maintains active and effective working relationships with managers and Operator's to ensure consistent and effective tuning practices
- Supports as a technical resource to develop, operate and maintain landfill wellfields
- Implements and manages wellfield maintenance plans in accordance with EDL Fuel Team
- Responsible for establishing, managing, and training wellfield technicians for best practices.
- Responsible for supporting landfill gas collection system trouble shooting activities and recommending improvements for internal consideration
- Supports wellfield construction management with onsite supervision of contractors as needed
- Manages fuel quality instruments to ensure delivery of fuel quality data to business
- Reviews gas field data to ensure effective delivery of fuel and regulatory standards are being upheld
- Fosters good customer relationships with owners and O&M providers.
- Works with consultants to ensure compliance is maintained in EDL NA wellfields

- 5+ years of landfill gas 0&M experience and general understanding of landfill practices
- Knowledge of relevant legislation, regulations, standards, and codes of practice relevant to landfill gas/landfill industry
- Must be able to travel to sites across the NA business regularly to perform duties as required
- Experience in operating and maintaining fuel quality instrumentation
